Two-page document, with notarial deed and deed of approval. The first deed is a sale granted by Pedro Collantes in favor of José de [illegible], priest of Cajatambo, of a male slave named Melchor. The deed seems to be incomplete; it has summary on the left of the text. According to official stamped paper, the date is 1708-1709. It has double original page number, one crossed out, 43 and another, 85. The following page contains an approval given by Martín José de Mudarra, corregidor, on the information presented by black woman [Teresa] Camposano, dated 2 October 1709, before Juan Geniz Terán, notary. On the back, a blank page. This is an original document (not a copy or testimony), signed by the grantor and notary Juan Geniz Terán; the handwriting is italic. The document is in a regular state of preservation, with perforations and weakened ink.

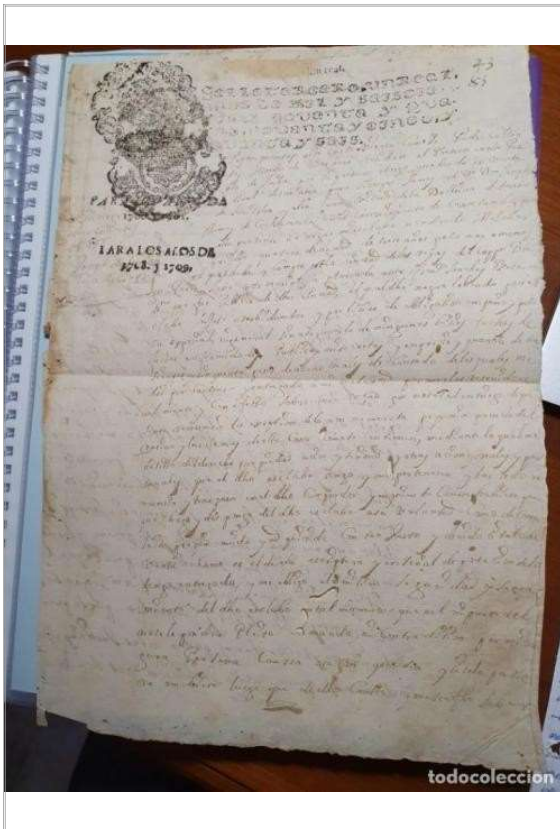


Image: Page 1, recto side.

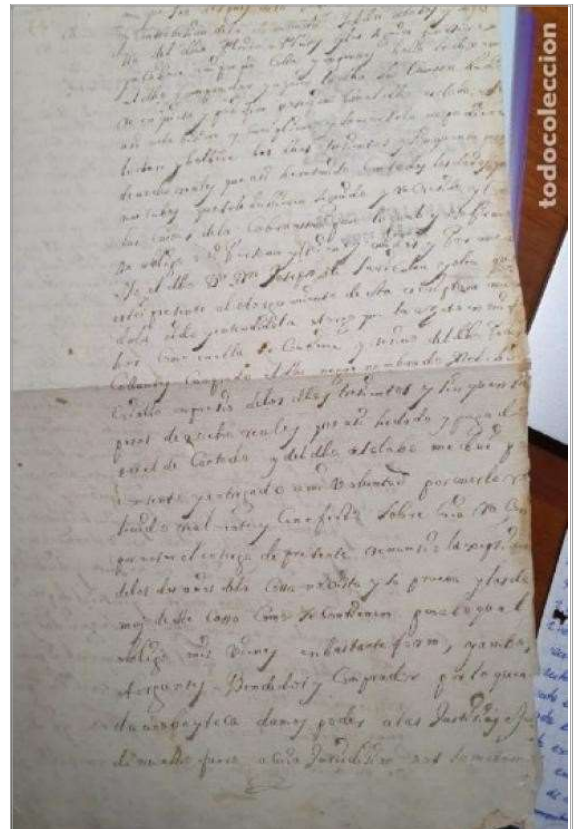


Image: Page 1, verso side.

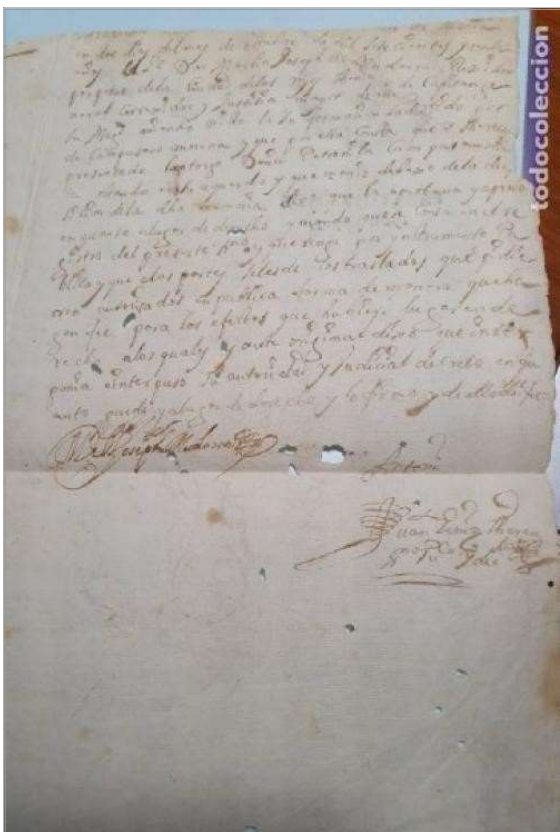


Image: Page 2, recto side.

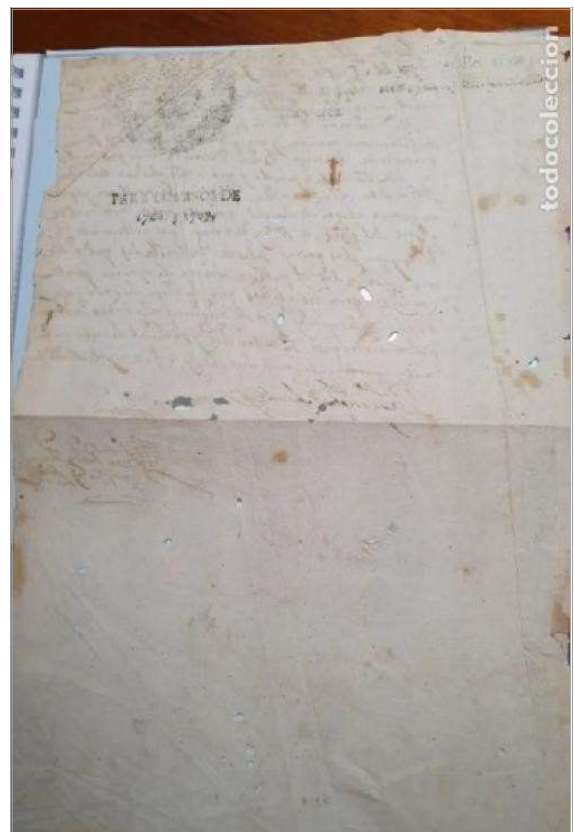
