**Description:**

Document of a folio, whose documentary type is a trade; it presents italic handwriting and letterhead with the denomination: "EJERCITO UNIDO LIBERTADOR DEL PERU" (*"UNITED ARMY LIBERATOR OF PERU"*), and on the right, annotation: "N.- CUARTEL GENERAL EN... A... DE... DE 1825", (*"N. - CUARTEL GENERAL EN... A... FROM... OF 1825"*), filled in manually: "- el Cuzco - 7, January". Issued at the Headquarters in Cuzco of the United Army Liberator of Peru, signed by Antonio José de Sucre and addressed to the Colonel Prefect of Arequipa, informing him that Lieutenant Colonel Don Luis Razeti, who as a result of the Capitulation of 9 December, is marching to that city to embark for Europe, asking him to verify and do his part to continue his journey; dated in Cuzco, 7 January 1825. The document shows an alteration in its form and support, the edges being cut out and, on the lower right, a trapezoid-shaped patch or rivet can be seen, very similar to the original paper

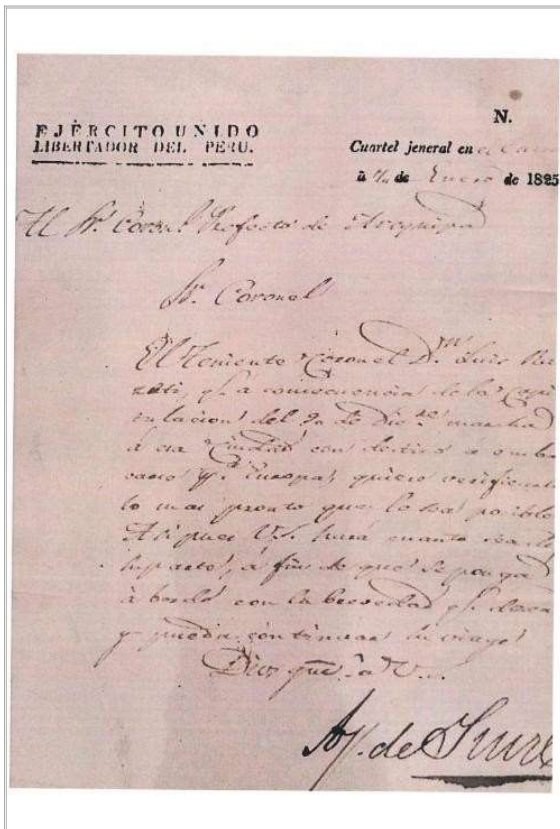
